→ WHAT TO DO NEXT

1. If you have **NO CHANGES** to your address, email or phone, simply pay your \$50 Renewal Fee to the Club Treasurer as instructed on **Section B** of the Renewal Form enclosed. Done!

OR

2. If you **HAVE CHANGED** address, email or phone, see **Section A** of the Renewal Form enclosed. Send an email confirming changes to Dave Coupland membershoppmea@gmail.com. Do not post.

Then pay your \$50 Renewal Fee to the Club Treasurer as instructed on **Section B** of the Renewal Form enclosed. Done!

→ NO ACCESS TO THE INTERNET

If accessing the internet for email or Direct Debit is an issue for you, a family member or friend may be able to assist with the email or the Direct Debit payment. Alternatively, you can visit your bank to arrange the Renewal Fee transfer to the Club's bank. Remember to follow the instructions on **Section B** of the Renewal Form. Cash or cheque will be accepted at a club meeting.

→ CONSEQUENCES OF NOT RENEWING BY 30 JUNE 2021

NB - A consequence of not renewing by **30 June 2021** means that you are no longer a financial member of a registered car club. After this date, if you have Historic or Classic Vehicle Registration it **will be illegal to drive as your registration and insurances will be invalid**, not to mention potential associated fines.
